(3) a semiannual progress report including attendance records and individualized documentation of the student's academic progress in each of the basic instructional areas specified in item (c) above.

Also note that Homework is assigned 20%, Mastery Tests 30%, Quizzes 25%, Participation 15%, and Organization 10%. These percentages are referred to here as weightage setpoints.

Weightage Setpoints: By allocating percentages to the listed categories, you essentially prioritize certain categories over others in assessing overall performance. For instance, assigning a 30% weightage setpoint to Mastery Tests indicates a greater significance compared to participation 15% and organization 10%. To ensure each category carries equal weight or importance in the course, an allocation of 20% to each category is recommended. Homeschools are not required to use this method.

SC Weighted Grading Scale (SC UGP) A=90-100, B=80-89, C=70-79, D=60-69 The weighted grade scale is formatted according to the Uniform Grading Policy, adopted by the South Carolina Legislature in 1999 for students entering 9th grade in the 2000-2001 school year. That policy, which applied to all students who first enrolled in the ninth grade in the 2000 01 school year, was revised in 2016 to a ten-point scale. Unweighted Grading Scale A=90-100, B=80-89, C=70-79, D=60-69

The unweighted grade scale is based on the standard four-point grading scale, A = 3.7 - 4.0 grade points, B = 2.7 - 3.3 grade points, C = 1.7 - 2.3 grade points, and D = 0.7 - 1.3 grade points. This scale applies when communicating with schools and educational institutions that do not recognize South Carolinas Uniform Grading Policy.


